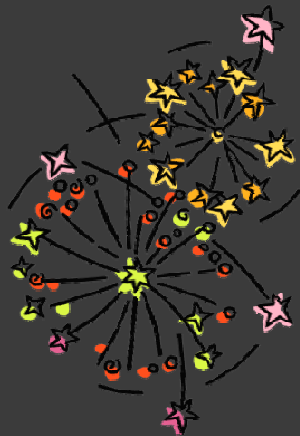

Elections

By now each chapter must have held elections for next year's officers. The Chapter Leadership Forms need to be submitted to the National office. 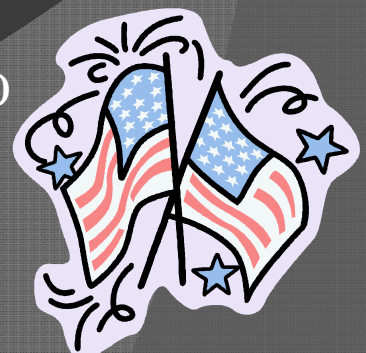
